

Note: before drafting a request for funding - applicants are encouraged to review the following funding criteria to see if your project fits.

The Children's Fund only supports projects in communities served by Access Communications Co-operative that are directed at children at risk or in need. Projects should address at least one of the following four focus areas:

- ✓ **Health & Well Being of Children & Youth** with a focus on programs which address:
 - a. the mental and physical well-being of children in need
 - b. children with diverse abilities
- ✓ **Education & Literacy** –programs which help improve educational performance
- ✓ **Poverty** - initiatives which create pathways out of poverty and provide for the relief of poverty and suffering of children and youth
- ✓ **Crime Prevention** – initiatives which discourage youth crime

Applicants that receive funding must be a registered non-profit or charitable organization.

The Children's Fund will not be the sole funder of any project and will not fund the same project for more than three consecutive years. Only one application per organization per year will be considered.

The Children's Fund does not support funding to the following:

- Individuals, or initiatives for youth over the age of 18
- Research, scholarships, loans, or endowments
- Fundraisers, auctions, travel costs, workshops or conventions
- Organizations offering services that are exclusive in nature
- Salaries, utilities, building maintenance and other organizational operating expenses; goodwill advertising or printing costs
- Political organizations; private day cares
