The Access Communications Children's Fund is our registered charity, and we're proud to have made great things happen in our communities.

Our Children's Fund supports organizations whose programs help children in three key areas:

- **Education and Literacy:** focusing on improving educational performance and reading comprehension.
- Health and Wellness: focusing on the mental and physical well-being of children in need and children with diverse abilities.
- **Social Inclusion:** focusing on creating a greater sense of belonging, acceptance, and recognition of diversity and culture for children and youth.

I'm pleased to advise that our Children's Fund donated over \$257,000 to 43 organizations during our last fiscal year, which ran from January to December 2021. This brought our total donations to well over \$2.8 million since our charity was established in 1992. Our charity will have many opportunities to continue its impactful giving.
