Our community programming on Access7 connects families, friends and neighbours, and celebrates life in our great communities. The 2,500 hours of local first-run programming that Access7 creates and broadcasts to over 90 communities would not be possible without the efforts of 235 volunteers who donate 600 hours each month to make it happen.

As a co-operative, Access Communications has a special connection with our volunteers. Each and every one of them demonstrates the desire to give back to their communities, and they show amazing enthusiasm and commitment to the people of Saskatchewan. Each year, Access honours and celebrates our volunteers by hosting appreciation events across the province during National Volunteer Week.

The Community-Producer Program provides the opportunity and supports individual volunteers and groups learn how to produce quality TV shows that will deliver their message to their own communities and audiences across the province. More than 55% of Access7 total programming is now produced by these local volunteer Community Producers. The more Access7 expands and revitalizes its mandate, roster of programming and hands-on community involvement—the more it attracts viewers, volunteers and compliments on programs such as the award-winning *Invisible Wall, The Four, Access7 Sports, RezX*—just to name a few! 



Report of the Independent Auditors

on the Summary Financial Statements

To the Directors of Access Communications Children's Fund Inc.

The accompanying summary financial statements of Access Communications Children's Fund Inc., which comprise the summary statement of financial position as at December 31, 2016, and the summary statement of operations and changes in net assets for the year then ended, are derived from the complete audited financial statements, prepared in accordance with Canadian accounting standards for not-for-profit organizations, of Access Communications Children's Fund Inc. as at and for the year ended December 31, 2016.

We expressed a qualified audit opinion on those complete financial statements in our auditors' report dated March 28, 2017.

The summary financial statements do not contain all the disclosures required by Canadian accounting standards for not-for-profit organizations applied in the preparation of the complete audited financial statements of Access Communications Children's Fund Inc. Reading the summary financial statements, therefore, is not a substitute for reading the complete audited financial statements of Access Communications Children's Fund Inc.

Management's Responsibility for the Summary Financial Statements

Management is responsible for the preparation of the summary financial statements, in accordance with the basis described in Note 1.

Auditors' Responsibility

Our responsibility is to express an opinion on the summary financial statements based on our procedures, which were conducted in accordance with Canadian Auditing Standard (CAS) 810, "Engagements to Report on Summary Financial Statements."

Basis for Qualified Opinion

In common with many not-for-profit organizations, the entity derives revenue from donations and fundraising, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, verification of these revenues was limited to the amounts recorded in the records of Access Communications Children's Fund Inc. Therefore, we were not able to determine whether, as at or for the year ended December 31, 2016, any adjustments might be necessary to donations or fundraising revenues and excess (deficiency) of revenue over expenses reported in the statements of operations and current assets and net assets reported in the statement of financial position. This caused us to qualify our audit opinion on the financial statements as at and for the year ended December 31, 2015.

Opinion

In our opinion, except for the possible effects of the matter described in the Basis for Qualified Opinion paragraph, the summary financial statements derived from the complete audited financial statements of Access Communications Children's Fund Inc. as at and for the year ended December 31, 2016 are a fair summary of those complete financial statements, in accordance with the basis described in Note 1.

1. Basis of Accounting
